**WALK – IN- INTERVIEW FOR THE POST OF JUNIOR RESIDENT ON AD-HOC BASIS TO BE HELD ON  
06/05/2024.**

Subsequent to the approval by Secretariat of the Election Commission of India vide letter No.437/ECI/DL-HP/2024/NS-II/MCC Ref dated 27/04/2024 to fill the vacant post of Resident Doctors during General Election to Lok Sabha 2024, Deep Chand Bandhu Hospital invites applications for a Walk-in-interview for filling up the vacant post of Junior Residents Doctors on Adhoc basis. Only candidates who fulfill the eligibility criteria as per Residency Scheme may appear before the interview panel on 06/05/2024 9:30 AM to 11:00 AM with their original documents.

**Qualification:-**MBBS Degree from a recognized University/Institution and must possess valid Registration Certificate from DMC.

**Internship:** Candidates who have completed internship earlier than 2 years at the time of interview shall not be eligible.(Must have completed internship by 05/05/2024 and not before 05/05/2022 preference will be given to fresh candidates).

**Pay Scale:** Pay of Rs.56100/- as per 7<sup>th</sup> CPC level 10 plus allowances as admissible under the rules.

**Age:** 40 years for General, 5 years relaxable for SC/ST and 03 years for OBC candidates (belonging to Delhi only) on the closing date of submission of application.

**Tenure:** The Maximum tenure of Junior Residents(MBBS) is for a period of one Year only including any service rendered as Junior Resident earlier on ad-hoc/regular basis in any recognized institution. The appointment will be initially period of 06 Month. Then tenure can be extended further upto a maximum period of 01 year subject to satisfactory performance, work and conduct report from concerned HOD.

In case non availability of Candidates under SC/ST/OBC/ Category, vacancies may be filled up from General Categories candidates for 89 days on Ad-hoc basis (or till regular candidate joins in respective category whichever is earlier).

Relaxation of provision as per circular No. F.121/26/2010/H&FW/1996-2045 dated 10.06.2011 of Deptt. of H&FW, GNCT of Delhi. If the fresh candidate is not available then following relaxation may be applicable:-

1. Upper age limit for eligibility for JR will be 40 years.

2. In case of non availability of fresh candidates, candidates who have completed one year Residency as J.R. may also be allowed to appear in the interview.
3. Separate merit lists for fresh candidates and for others (i.e. those who have already completed one year Junior Residency) would be prepared.
4. Firstly, the list containing the names of fresh candidates would be exhausted for appointment and the second list would be used only after that.
5. Reservation of Person with Disability will be as per Government Rules.

Other conditions/requirements:-


**Hostel accommodation is compulsory.**

- i) The candidates who are already in govt. service should submit an NOC from his/her Employer.
- ii) The services of Junior Residents shall be governed by residency schemes of Govt. of India/Civil Services (Temporary Rules).
- iii) Candidates are required to bring all original certificates and testimonials along with two passport size photographs on the date of interview.
- iv) Appointment shall be subject to medical fitness & verification of certificates.
- v) No TA/DA will be paid for appearing in the interview.
- vi) Reservation of Person with Disability will be as per Govt. Rules.

Submission of application:-

- a) Interested and eligible candidates may apply in the prescribed format with self attested copies of all testimonials and certificate i.e list of documents Date of birth certificate (Metric Certificate), MBBS, Internship Certificate, FMGE(05/05/2022 to 05/05/2024). MBBS Degree/Diploma, Mark sheets, attempt Certificate, Caste Certificate, income certificate (in case of OBC & EWS Candidates issued within Six months). Experience Certificate, if any, DMC registration Certificate and Proof of Permanent Address/Aadhar Card . Application after 11:00 AM will not entertain. **Without DMC certificate not accepted.**
- b) Those candidate with applied for MBBS in DMC if Selected will be appointed on adhoc basis for 44 days, they should submit valid DMC certificate of MBBS within 44 days from the date of joining otherwise their candidature will be terminated after 44 days.
- c) Those candidates who applied with 01year experience post MBBS should have valid DMC certificate of MBBS (Delhi).
- d) Application received will be scrutinized and all such applications received incomplete or without proper enclosures will be rejected.


